On May 27, 2024, the Board of Directors (“**BOD**”) of Vingroup issued Resolution No. 09/2024/NQ-HĐQT-VINGROUP (“**Resolution No. 09/2024**”), approving the transfer of all shares owned by Vingroup (accounting for 99.914% of interests), in NVY Viet Nam Development Joint Stock Company, enterprise registration code No. 0202239055 and headquarters at No. 1 Hanoi Street, Thuong Ly Ward, Hong Bang District, Hai Phong City (“**NVY Vietnam**”), of which, 19.914% interest in NVY Vietnam will be transferred to Vinhomes Joint Stock Company, enterprise registration code No. 0102671977 and headquarters at Symphony Office Building, Vinhomes Riverside Eco-Urban Area, Phuc Loi Ward, Long Bien District, Hanoi City (“**Vinhomes**”). Upon the completion of the transfer, NVY Vietnam will cease to be a subsidiary of Vingroup.

Simultaneously, under Resolution No. 09/2024, the BOD approved the signing and implementation of contract(s)/agreement(s) with Vinhomes regarding the investment, development, construction, exploitation and operation of a part of the entertainment, residential, and ecological park on Vu Yen Island, Hai An District and Thuy Nguyen District, Hai Phong City, Vietnam.
