2. Contents of information disclosure:

On 25 June 2025, the Board of Directors (“**BOD**”) of Vingroup issued Resolution No. 15/2025/NQ-HDQT-VINGROUP (“**Resolution No. 15/2025**”).

Pursuant to Resolution No. 15/2025, the BOD of Vingroup approved the provision of a payment guarantee and the usage of Vingroup’s assets (“**Secured Assets**”) as security for the corporate bonds issued by VinFast Trading and Production Joint Stock Company, a company having enterprise registration certificate No. 0107894416 and head office address at Dinh Vu – Cat Hai Economic Zone, Cat Hai Island, Cat Hai Town, Cat Hai District, Hai Phong City, Vietnam (“**VinFast**”), which are denominated in Vietnamese dong, non-convertible, without warrants, secured by assets, issued by and constituting a direct debt obligation of VinFast with the maximum total par value of VND 2,500,000,000,000, due in 2028 (the “**Bonds**”).

Simultaneously, the BOD assigned the Chief Executive Officer – the Legal Representative of Vingroup or other person authorized by the Chief Executive Officer, based on the actual situation and further decision on the details of the guarantee, number of secured assets corresponding to the Bonds executed and issued by VinFast, to perform the Contract/Agreement with relevant parties in accordance with the approval of the BOD and the laws.
